Some people must have disagreed with the politicians and among those is Dr. M.S. Craig, of Little Rock, Arkansas, who wrote the following in a letter: "Colonel John Wilson, Jr. who killed J.J. Anthony in 1836, on the floor of the House of Representatives, was a very prominent gentleman. The historians have been less than kind to him because of this homocide. But --- I saw: "Tis no crime to save one's life with Bowie knife." --- The dispute between Colonel John Wilson, Jr. and Mr. J.J. Anthony arose from the subject of whether wolf-scalps should be considered legal tender. Wilson was severely knifed by Anthony, but managed to survive. Wilson was Speaker of the House of Representatives. The day following the killing of Anthony, Wilson was expelled by the House. There had been "bad blood" between Wilson and Anthony prior to the fatal episode. Each combatant used a Bowie knife. Wilson was the physically smaller of the two. He was a relativelly small, but agile man - - - a brunette with dark complexion. When the episode occurred, Wilson was the first President of the Real Estate Bank of Arkansas. Wilson is to me extremely interesting and a complex individual. The history books scarsely mention him. He deserves far, far better treatment than this! - - - "

Hardin is Joseph Hardin, the Sherriff of Lawrence County and the Colonel of the Third Regt. of the Territorial Militia of Arkansas, and a great, great grandfather of Marion Stark Craig, MD., the compiler of this compilation. This Joseph died at Davidsonville, Lawrence County on 25 Aug 1826.

1819 "Fulton has a history older than Hempstead county. It was a landing place and a point of considerable note as early as 1819, at which date quite a colony of people lived there. Many of the earliest settlers in the county came up Red river on keel and flat boats and landed at Fulton. This was before the era of steamboats.

Along with these early pioneers came Col. John Wilson, who represented Hempstead county in the lower house of the Territorial Legislature from 1825 to 1829 (Daniel T Witter being Senator during the same period), who was President of the Constitutional Convention, as well as a member and speaker of the House of Representatives in 1836, who made himself notorious for killing Assemblyman Anthony on the floor of the House. The Mosses--James, William and Matthew--, the Gibsons, Campbells, Nelsons and others also landed ar Fulton upon their arrival, and for a time remained there. Col Wilson came in 1819, and lived there guite a while. On one occasion he rode out into the forrest with his rifle--every man carried a rifle in those days--and while out killed a wild hog, which he slung onto his horse and rode back to the settlement--it could hardly be dignified by the name of "town" then. On arriving there one of the other settlers claimed the porker, and accused Wilson of trying to steal it; whereupon the l;atter dismounted, laid aside his gun, and gave the fellow a sound thrashing with his fists, telling him at the same time that he would kill him only for the fact that men were already too scare in the county. From Fulton, Wilson went to Washington and lived for a while. From there he moved out to the black lands and improved the place afterward owned by Judge Cross. The house in which he resided stood opposite, and almost within gunshot of the one in which the late John W. Williams lived for years. He next removed to Clark county, locating on Wolf Creek, and represented that county in the Legislature at the time he slew Anthony. The late Judge Witter has been heard to remark that but for this unfortunate episode Wilson would undoubtedly have been the next Governor of the State. It proved his ruin politically and financially.. He was expelled from the House of Representatives and never afterward held any office, and his fortune, which was not large, was pretty well exhausted in defraying the expenses incident to his trial and acquittal. A few years afterward he emigrated to Texas, where he lived to be a very old man, but has long since been dead. Wilson never had but one son--Richard--and he was killed in a personal encounter, at Arkadelphia, by H. K. Hardy. They were both lawyers. (Printer's Devil, by Sam Williams, No. IV, Fulton's Early History, 58 & 59 p., Via Irene Varan, Georgetown, TX., 27 Apr 1994.)

Col. Wilson was a very popular man throughout the state and the leader of the party and would have been governor if he had asked for that position.... The knieves used were over 15 inches long. I saw them exhibited on the day of Wilson's trial in Benton... Wilson was tried and acquitted. He had many warm friends and I blush not to own it." (Dr. Smith's Scrapbook, 1-4 p., T/A.)

1815 Richard Andrew "Dick" Wilson was born in Missouri; while not proven to date, evidence points to Willis Wilson and Nancy Pyburn Wilson as his parents. Also there is this info, "A. W. Wilson, the well-known clerk of Clark Co. Ark., is a native of the county, and on account of his long acquaintance in the vicinity, is held in high esteem by all who know him. His birth occurred on the 22d of April, 1855, and he is a son of Willis and Sarah A. (Wells) Wilson, the former a native of Missouri, and the later of Clark Co., Ark. The former was taken by his parents to Arkansas when he was a infant, and here he was reared to manhood, being one of the first settlers of this region." This Willis Wilson appears to be the son of Leonard Wilson, who is found in Missouri Census abt the time of his birth, Abt 1823. Willis Wilson-101 was already in AR at this time. Leonard & John Wilson are both found in Hempsted Co. AR., in 1830 Census. (The Goodspeed Biographical & Historical Memoirs of Southern Arkansas, Clark Co., p180. Clayton Lib. This is included to help sort out the Willis Wilsons in this area one from the other,)

1815/1818 It appears that between 1815 and 1818 Willis Wilson and family moved from Missouri to Hempstead Co., Ark.

"About the year 1818 there were few Baptists in Clark and Hempstead counties and a church was organized at Antioch, in Hempstead County, near the present beautiful town of Prescott, by the following brothers and sisters: Willis Wilson and lady, Mrs Peaty Aaron Bolt, Mr Coutly, John David and lady, and others, who have been forgotten,... "All this information I have learned from reliable Baptists (messrs. Wilson and Lewis) up to 1833 from that time I have witnessed the balance in person." "There is one occurence that took place there in Prairie DeAnn (Antioch is the name I think). A Mr. --Neil moved his stock of goods in the neighborhood of the church in the spring of 1832 and was taken very sick and was of the opinon that his hours of life were growing short and desired to be Baptized by immersion before he took his final exit or departure. There having been no minister there for several years and most of the church members having moved off or died, the few old members met in the church to consider the matter and see what could (be done). After examining him and hearing him relate his travels, his conviction and conversion, they became satisfied that a change had taken place (a newness in life) considered him a fit subject for Baptism and decided that the deacon be the right one to m the ordinance of baptism. Mr. Neil was so sick that he had to be and from the water on a chair, the water being about two or three

feet deep. Then deacon John Lewis immersed him by the help of Willis Wilson, Aron Bolt, and Joshua Fuqua, church members in good standing. I was introduced to Mr Neil in 1838 by Mr. Fuqua, quite a worty man.... Mr. Neil recovered and made a reputable member of the church." (Dr. Smith's Scrap Book, p 33 & 34 as published, Doctor Willis S Smith, by the Robert Speer Chapter, National Society Colonial Dames, San Antonia, TX.,T/A)

These are brother's to Willis Wilson, with John Wilson Sr. the father.)

1830 Census of Missouri listed John Wilson, Benjamin Wilson, & James C. Wilson all on page 429; William Wilson, & John Wilson on page 435. Richard Pyburn is shown on page 439.

(Family Background of "Grandma"-Ida Young, given to Earline Webb 6 Aug 1955, supports the assumption that this is most likely the correct Wilson family group.)
